2020 Accomplishments

- COVID-19 Operations- SCCEMS paramedics have performed heroically during the ongoing COVID-19 pandemic. SCCEMS has been able to be successful in keeping staff health to maintain operational capabilities as well as maintaining personal protective supply lines to meet operational needs. The organization has obtained alternative funding resources to reimburse for added expenditures and reimbursement challenges during the pandemic.
- Strategic Plan Development: Phase II of the SCCEMS Strategic Planning process was completed in consultation with Carter and Pugh Associates. Phase II involved developing mechanisms and resources for the organizations upcoming capital campaigns.
- **Municipal Funding Formula-** After two years of meetings between our municipal partners, consensus was achieved transitioning SCCEMS from a millage based municipal funding request to a blended average request. This formula will be used starting in 2021.
- New Website- SCCEMS completed the transition to a redesigned website which will offer additional features and enhanced expansion of the MEDIC 94 branding efforts.

Budget Overview

- The 2021 SCCEMS Operations Budget is a balanced budget.
- Capital expenditures related to the 2021 Capital Campaign purchase of new cardiac monitors are a separate budget item
- The budget was developed with revenue and expenses assumptions in all categories at CY 2020 levels. .
- Expenses budgeted 3% lower than CY 2020. Some of this reduction is the budgetary restructuring of the major capital campaign items.

2021 Operational Objectives

Initiation of Strategic Plan Goal 1- Multi Services Quality Assurance/ Improvement Committee

The EMS system in southern Chester County has always had a regional focus for coordination and operations. In 2021, taking the next step in this collaboration by further developing the basic and advanced life support team clinically through a joint quality team as outlined in the SCCEMS Strategic Plan.

Partnership Opportunities with Tower Health

Now in the 3rd year since Tower Health became a community healthcare partner, opportunities for partnerships in community outreach, training, clinical coordination and system integration continue to be on the horizon. With COVID and changes in the corporate structure at Tower Health, many of these opportunities have yet to be explored. An independent yet interdependent focus will be explored.

Capital Campaign

SCCEMS will begin a capital campaign in 2021 for the purchase of 3-4 Philips Tempus Pro cardiac monitor defibrillators. The devices, which are used by our paramedics on every patient contact replace existing monitor defibrillators that are over 15 years old. These devices will significantly enhance our paramedics capability to assess and treat our patients and communicate and document those findings.

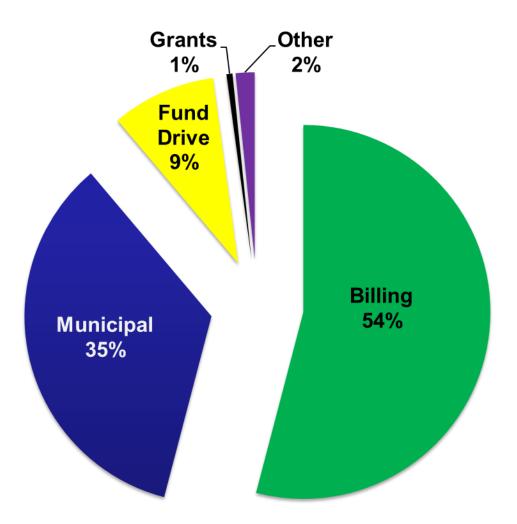

Billing Revenue Overview

- SCCEMS bills patients and their insurance for services provided.
 - Billing rates unchanged for 2021.
 - Billing service fees unchanged for 2021
 - Rates are based on Medicare bundled levels
 - Increased insurance payors funding in Medicare model which decrease revenue by 80%
 - Collections revenue reflected into patient billing revenue category.

FY 2021 Revenue



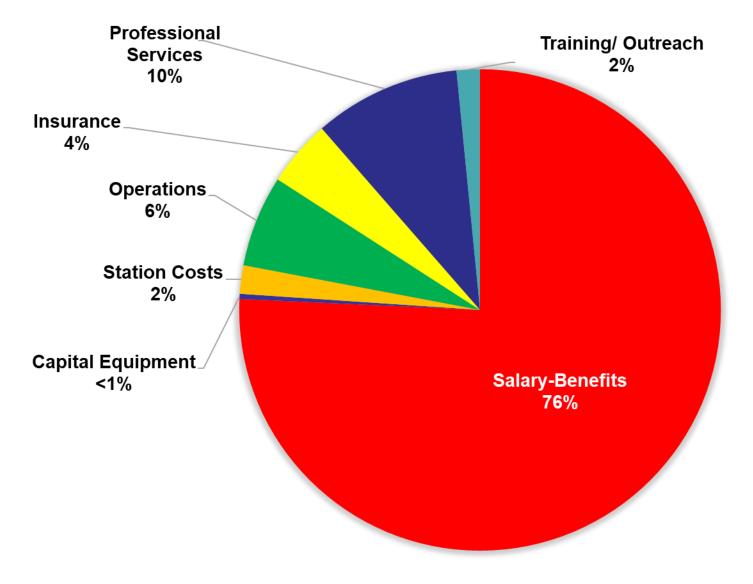
