





2022 Municipal Funding

MEDIC 94 could not provide our valuable life-saving services to the community without municipal support. With the closing of Jennersville Hospital and the increased cost of adding staff and a power truck, we challenged our municipalities to provide extra funding in 2022 to offset those additional expenses required to expand services. In 2022, we received \$541,023 in municipal support. All of our municipal stakeholders provided funding with 11 of the 17 proving 100% of the standard and supplemental funding requested and 5 providing 100% of the standard request.







Finances- Reserves

MEDIC 94 maintains Board-restricted reserves managed by a professional advisor. These funds were obtained in 2001 when MEDIC 94 separated from the former Southern Chester County Medical Center corporate structure. The funds were the result of fund-raising activities prior to 2001 by the hospital on behalf of MEDIC 94. In 2003, the initial distribution of \$750,000 was drawn down to \$504,000 to pay off transitional losses the first 2 years after separation from the hospital. Since that time, the initial \$504,000 has been invested. Gains in those investments were first used in 2017 to fund capital projects. In 2022, MEDIC 94 utilized \$200,000 to fund operations and capital equipment.



Operational Highlights

In 2022, MEDIC 94 made several changes to our operational capabilities due to the closing of the Jennersville Hospital. Expecting higher call volume and longer transport times, an additional "power truck" was staffed between the hours of 9am and 7pm daily. The "power truck" supplemented the two 24/7 MEDIC 94 units operating from Jennersville and Avondale and was staffed 73% of the time and handled approximately 15% of total dispatches.





For the past several years, MEDIC 94 had four EMS Sergeants who assumed several operational duties in addition to their assigned shifts. Through discussion with several sergeants that had left those positions, it was determined that the dual responsibility in addition to running calls was not effective. Accordingly, two EMS Sergeant positions were eliminated and an Operations Chief position was established. Paramedic Matt Collins was promoted to that position in August.

Operationally, MEDIC 94 completed their first year of utilization of the Philips Tempus Pro cardiac monitor defibrillator on the primary units and began training for the implementation of the video laryngoscopy option which occurred in December.




Stations

Based out of the former Jennersville Hospital,-this station houses the headquarters as well as MEDIC 94-1 and MEDIC 94-2.




Avondale Station

Dispatches By Municipality




Mutual Aid

In 2022, MEDIC 94 responded to 163 mutual aid calls assisting neighboring services. Those responses represented 5% of total call volume.


On 71 (46%) of those dispatches, MEDIC 94 paramedics transported the patients.


MEDIC 94 required mutual aid assistance from neighboring ALS units 129 times in 2022. On 88 (69%) of those dispatches, the neighboring ALS unit transported the patient.




Call Outcome

The closing of Jennersville Hospital impacted call outcome, dropping the number of transported calls from 65% to 59 % and increasing releases to BLS from 5% to 11%. These patients are those that after a paramedic evaluation are determined to not require advanced life support services enroute to the hospital. These clinical determinations are made by MEDIC 94 paramedics in consultation with medical command physicians at emergency departments and the basic life support ambulance crews.







Receiving Hospitals


With the closing of the Jennersville Hospital on New Year's Day 2022 and the closing of Brandywine Hospital a month later, MEDIC 94 paramedics were required to transport patients to more distant hospitals. As a result, almost 60% of patients were transported to out-of-state facilities. There was a 47% increase in transport times. Further complicating operations was were the wait times upon arrival at several hospitals, which at times was over an hour waiting for hospital staff to assume care.

MEDIC 94 saw a more than 10-fold increase in the number of patients being transported to the Union Hospital since the closing of Jennersville Hospital



Average Transport Call Times






Time Cycle of a MEDIC 94 Call 2022




Due to the closure of Jennersville Hospital at the end of 2021, the primary impact to operations besides the increased call volume has been the increased amount of time that a transporting call requires. In 2022, total call times increased 17% from 63 to 73.4 minutes and transporting call increased 30% from 86 to 112 minutes.




Dispatches by Time of Day

Dispatch Patient Contacts





MEDIC 94 operates five Pennsylvania licensed Advanced Life Support vehicles. Four of the vehicles are in rotation at the stations and one vehicle serves as a utility/officer's response vehicle. All of the vehicles are either Ford Explorers or Expeditions purchased under state contract and upfitted locally. These vehicles, costing approximately \$60,000 when complete, have an 8-year service life.

In 2022, SCCEMS took delivery of a new Explorer. The vehicle replaces a 9-year-old vehicle with over 150,000 miles. In late 2022, MEDIC 94 placed an order for a 2023 Ford Explorer to be placed into service in the 1st quarter of 2023.

Training



For MEDIC 94 paramedics, training never ends. In addition to state and national continuing education, our staff is always learning new techniques and procedures. On an ongoing basis, the EMS medical Director Dr. Simon provides individual and organizational training and skill competency checks.

This past year, increased training was completed on our new Philips
Tempus ALS cardiac monitors as well as patient sedation procedures and
drug facilitated intubation medications. With the addition of prehospital antibiotic therapies carried by MEDIC 94 paramedics for
complicate sever fractures, in servicing by all staff was required.
In addition to internal training of staff, SCCEMS is a preceptor site for
both JeffStat and the Goodfellowship Ambulance paramedic schools.
SCCEMS paramedics mentor these students through the field-training
portion of their training.













Goodbye Jennersville Hospital

We said goodbye to our friends at Jennersville Hospital on 31 December when Tower Health closed the hospital. For over a century, ironically from the Spanish Flu pandemic through the COVID pandemic, the hospital has provided healthcare to the community. MEDIC 94 was founded back in 1983 under the hospitals former name SCCMC. SCCEMS was part of the hospital corporate structure up until 2021 and while we became a separate entity, we never moved away. We've been calling our facility just next to the emergency room our home for 40 years.

We considered the caring and dedicate hospital staff family. Many MEDIC 94 staff members worked for both the hospital and the medic unit at times. We saw them every day that we worked. We brought over half of our patients into their trusted care. We laughed and cried together. Celebrated birthdays, graduations and retirements. We were family.

We will miss our friends and cherish the memories and look forward to the hospital's reopening in the future.









We are excited that ChristianaCare has purchased the hospital and plans on opening it up as the ChristianaCare West Grove Campus in the future. We look forward to the days when the doors are back open, dedicated caring healthcare professionals are back in the walls of the building and our community regains the trusted healthcare partner that it deserves.
